After your course, you must present your certificate of completion and pay the **court cost of \$159.00** on or before your court date listed above. If you pay before your court date, you may pay the court cost at the *Albertville Municipal Court* office located at the above listed address. If you pay on your court date, you will pay in the *Albertville Municipal Courtroom* at your scheduled court date and time. The *Albertville Municipal Courtroom* is located at 116 Sand Mountain Drive SW, Albertville, AL.

\* If court cost is not paid on or before your court date, your ticket will not be dismissed. We accept cash, credit card, debit card, money order, and cashier's check as forms of payments. Personal check are **NOT** accepted. There is a 3.9% convenience fee for credit/debit card charges.
