



## SCHEDULE OF FINES FOR TRAFFIC OFFENSES

### NOTICE TO DEFENDANT TRAFFIC CASES

You **MUST** either come to court on the date and time shown under "COURT APPEARANCE INFORMATION" on your traffic or pay the ticket **BEFORE** your court date. **SEE INSTRUCTIONS FOR PAYING TRAFFIC CITATIONS** below as to what ticket can be paid without coming to court.

1. A warrant will be issued for your arrest
2. Your driver's license will be suspended and it cannot be reinstated until the ticket is cleared and reinstatement fee is paid.
3. The court cost will be automatically increased by a minimum of \$20.00.
4. The fine is subject to being increased.
5. Any bond you have posted may be forfeited.

### INSTRUCTIONS FOR PAYING TRAFFIC CITATIONS

If you have been charged with one of the listed offenses and would like to pay the fine without appearing in court, please sign below and mail the fill amount indicated to the address below. Mail a **MONEY ORDER** or **CASHIERS CHECK (NO PERSONAL OR BUSINESS CHECKS WILL BE ACCEPTED)** payable to Municipal Court of Albertville. Payment must be received before your court date.
